San Gabriel Valley Water Company ("San Gabriel") hereby submits one original and four copies of the following changes in tariff sheets applicable to its Los Angeles County Division:

**Purpose and Background**

The purpose of this advice letter, submitted in accordance with Section X.A of General Order No. 96-A, is to seek approval to amend the list of contracts and deviations tariff sheet to reflect a customer substitution of Arbor Nursery with the present nursery at the location, Chuy's Nursery. All terms, except for an added non-assignability clause, of the reclaimed water service agreement negotiated with Chuy's Nursery on May 9, 2007, are identical to the terms in Arbor Nursery's agreement, approved by Commission Resolution No. W-3882, dated October 12, 1994.

Because this advice letter seeks approval only of a customer substitution for a specific reclaimed contract service agreement with no changes in rates, no restrictive conditions or a withdrawal of service, San Gabriel believes that a Commission resolution is not necessary to approve this filing. Advice Letter No. 352 is a Tier 2 advice letter.

**Notice**

No individuals or utilities have requested notification of filing of tariffs. Distribution of this advice letter is being made to the attached service list in accordance with General Order No. 96-A, Section III-G.

**Protest and Responses**

Anyone may respond to or protest this advice letter. A response supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

- (1) The utility did not properly serve or give notice of the advice letter;
- (2) The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- (3) The analysis, calculations, or data in the advice letter contain material error or omissions;
- (4) The relief requested in the advice letter is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- (6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require relitigating a prior order of the Commission.)

A response or protest must be made in writing or by electronic mail and must be received by the Water Division within 20 days of the date this advice letter is filed. The address for mailing or delivering a protest is:
